Report on Agreed-upon procedures Performed on Expenditure incurred for International Democracy Day

We have performed the procedures agreed with you vide Engagement Letter dated October 07, 2024 with respect to the Expenditure incurred for International Democracy Day, Our engagement was conducted in accordance with the Standard on Related Service (SRS)4400 on "Engagements to Perform Agreed-upon procedures regarding financial Information", issued by the Institute of Chartered Accountants of India. 'the procedures were performed solely to assist you in evaluating the accuracy of Expenditure incurred for International Democracy Day,

The objective of this engagement was to carry out the specified procedures and report factual findings based on those procedures.

- 1. Verified the total expenditure incurred for International Democracy Day against the supporting invoices and receipts.
- 2. Checked the authorization and approval of the expenditures by the relevant authorities.
- 3. Reviewed the documentation for compliance with applicable laws and regulations.

We report our finding below:

- 1. The total expenditure incurred for International Democracy Day was (refer to Annexure).
- 2. All expenditures were supported by valid invoices and receipts.
- 3. The expenditures were properly authorized and approved by the relevant authorities.
- 4. The documentation was in compliance with applicable laws and regulations.



- 5. Receipts of Rs. 25,00,000 from Canara Bank and Rs. 1,18,50,000 from the Social Welfare Department, as shown in the annexure, were not received in the bank account. Instead, these amounts were directly paid to the respective vendors and the 31 Districts by Canara Bank and the Social Welfare Department, respectively. These amounts are also reflected on the payment side, resulting in no net effect on the overall accounting.
- 6. In the payments, except for Rs. 2,75,000 for postal services, all amounts were paid to a single vendor, Karnataka State Marketing & Advertising Limited. No quotations were obtained from other vendors as Karnataka State Marketing & Advertising Limited is exempted from the requirement of obtaining quotations under the provisions of Act 1999, Clause 4(G).

The above procedures do not constitute either an audit or a review made in accordance with the generally accepted auditing standards in India, we do not express any assurance on the findings reported above.
